## **TOBIANO GOLF PRIVACY POLICIES & PROCEDURES**

Tobiano has adopted the Personal Information Protection And Electronic Documents Act [2000,c.5], which governs the collection, use and disclosure of personal information. We consider your personal information to be only that information necessary to communicate services, special events and functions to you related to Tobiano's golf facilities. Tobiano will not disclose any personal information, which we have collected from you to other parties except as permitted by legislation or with your consent. At any time you may contact us to review the personal information we have on file for you. You may request changes or deletions as you see fit.

#### **Dress Code**

All golfers and non-golfing riders must adhere to the Tobiano Dress Code. Please see the website <u>www.tobianogolf.com</u> for full details.

#### **Footwear Policy**

Tobiano requires the use of soft-spiked golf shoes or soft-soled shoes on the course, no metal spikes permitted.

#### **Junior Golfers**

An adult guardian MUST accompany all junior golfers (up to the age of 17). Players must have their own set of golf clubs and must get the approval of the golf services supervisor before they are allowed to play. Junior golfers (ages 17-18) must have a valid N drivers license to be able to operate a power cart. A credit card must be on file for any junior member that is eligible and wanting to operate a power cart.

#### **Non-Golfing Riders**

Due to golf volumes, players are limited to one non-golfing rider each, based on power cart availability. There is a charge of \$25.00 + GST per rider for 18 holes. Non-golfing riders must be over the age of 12 for safety reasons; small children or infants are not permitted on the golf course.

#### **Power Cart Policy**

Power Carts are mandatory and are provided with a state of the art G.P.S. System to assist in golfer enjoyment. There is a maximum of 2 players and 2 sets of clubs per golf cart.

Evening play times will change with the seasons during the year.

# **Member's Guests**
